This form is in electronic form, so you may fill it on your computer except for the signatures and the recipient information before printing.

You may print three copies of filled forms right away or copy one of the forms you have printed. After that all three forms (3 pcs) should have all the signatures of new and old owners.

DECLARATION OF OWNERSHIP

The declaration of ownership must be filled as **three pieces**. The buyer must sent the first form to Suomen Hippos, the second one stays to the buyer and the last one belongs to the seller.

By this form you inform change of ownership **before enrolling horse to next competition or at last within 14 days of the change.**

Note! It is reasonable for seller and buyer to make a contract of sale, where more detailed agreement on the terms of trade are made. This contract of sale does not have to be sent to Suomen Hippos.

- 1. Inform **date** of changing the ownership.
- 2. By informing the wanted information about the horse you may not be asked further information.
- The form has space enough for three old owners' information and space for one new owner. The form must have all information of both OLD and NEW OWNER. If needed fill in the registration notice of joint ownership.

If a foal is being registered by someone else than the breeder, then must be the declaration of ownership given to a horse identifier.

- 4. The new owner's banking account information can be informed with the declaration of the ownership to a column reserved for them.
- 5. All horse's new and old owners fill in the same form.
 If a horse is owned by a name of stable, the form must be signed by an official representative, who is also announced to Suomen Hippos.

On behalf of underage owner the form is signed by a guardian.

- 6. The declaration of ownership must be delivered to SUOMEN HIPPOS.
 - A) Directly, for example by post: horse's passport or certificate of registry must be delivered at the same time
 - B) Through Horse breeding association's office or racetrack's office: with passport or certificate of registry. The association or racetrack delivers the form to Suomen Hippos.
- An official by Suomen Hippos, Horse breeding association or racetrack writes the new owner to the horse's passport or to the certificate of registry and verifies it by a stamp.
 OWNER OF THE HORSE CAN IN NO CIRCUMSTANCES MAKE ANY MARKS TO THE PASSPORT OR THE CERTIFICATE OF REGISTRY! Mark made by owner is void.
- 8. If a horse is owned by a joint ownership or name of stable, must those also be registered to Suomen Hippos.
- 9. If the declaration of ownership is delivered late is higher payment being charged. Also possible old change of ownerships unmade are charged from the new owners.
